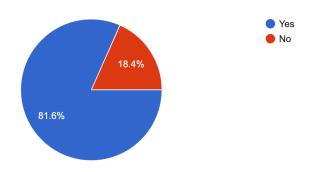

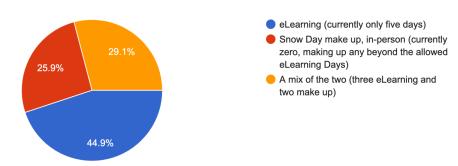

Superintendent Report to School Board February 13, 2023 Sherri Broderius

Celebrations:

- 1. MACCRAY has been awarded a grant through Woodland Centers to have a School Linked Substance Use Counselor. Because we already have School Linked services and because last summer I accepted the invitation to meet with Woodland Center and because Woodland Center wrote an awesome grant letter our students will have access to first, PREVENTION then to intervention when necessary. Here is what Kim Hansen said about the grant: "Our model of SUD prevention, intervention and direct service was favored by the Department of Human Services and they commented on our clear relationships with each other and feel that integrating our existing mental health services with substance use services will be incredibly beneficial for the students we all serve.
- 2. Our new art teacher Jasmine Goblish has completed and submitted a grant to the Perpich Center funds to create opportunities for MACCRAY arts staff to work collaboratively. This would include money for opportunities for students to attend arts field trips and professional development opportunities. We will see if Perpich Center views this in a positive light.
- 3. School Board Appreciation Month I would like to gather right after the board meeting to get a picture of all of you together so I can put it on the website with our appreciation.

Purchase Agreements:

- The Purchase Agreement for the Maynard building was returned to me as "not recordable" The agreement was sent immediately to our attorney to complete three items. A. Pay for deed stamps.
 - B. Complete the electronic Certificate of Real Estate.
 - C. Change ISD from 127 to 2180 to identify the school.
- 2. I have the first draft of the purchase agreement for the Raymond building. I haven't had time to work through it yet with ICS, Jim, Kim and anyone else just to make sure it's good to complete.

Contracts:

- 1. One of our largest personnel contracts is with the Southwest West Central Service Coop. It is during this time of year that we evaluate this closely to determine services we will purchase for the next school year. I will talk more about this on Monday night.
